A Message From President Fred Zuckerman

The IBT is currently engaged in negotiations with YRC Worldwide, which includes YRC Freight and USF Holland. This is one of the most important national master agreements in the Teamsters union, and member expectations are high.

During negotiations in 2009 YRC was in very bad shape due to the recession that began in 2007 and 2008. Because of this, the IBT took the near unprecedented step of agreeing to a 15% reduction in wages across the board in order to help keep the company afloat. YRC also went into deferral on their Central States Pension Fund contributions. When they re-entered in July of 2011, they did so at only a 25% rate and have stayed at that rate ever since. This has given our members only a fraction of the pension they deserve over the last eight years.

Over these last years the concessions in wages and pensions has saved the company at least six billion dollars at our members expense, yet as of today YRC Worldwide is still claiming they have no money to spare. Despite this, they had ample money to buy up smaller companies and expand their empire since 2009, all with money they saved as a result of concessions given to them by the IBT.

This must end. YRC has been allowed to gut our members paychecks and retirement for far, far too long. The 15% reduction to wages must be eliminated, and wages must be brought up to today's union freight standard. YRC's pension contributions must also be fully funded. The IBT cannot allow the company to continue contributing a fraction of what our members have right-fully earned.

The IBT claims that negotiations are going smoothly, but they are still only dealing with non-economic proposals. It is the economics that will determine whether this negotiated contract is worthy of our hard working YRC and USF Holland members, or if it is worthy of a strike.

Carhaul Grievance Victory

On October 18th, 2018 Teamsters Local 89 Carhaul member Ken Brown Jr. was wrongfully discharged by his employer, Jack Cooper Transport, for an alleged seat belt violation. As of Thanksgiving, Brown Jr. had returned to work and was "made whole" with full restoration of his lost pay, pension accrual, and benefits.

Brown Jr., who works out of the Ford Kentucky Truck Plant (KTP) had been on a haul on October 8th when he was pulled over by a Kentucky State Trooper who alleged that he was not wearing his seat belt. Although Brown Jr. contested his innocence, he was given a ticket which carried a score of 7 points on his Compliance Safety and Accountability (CSA) score. The CSA is essentially a "report card" used by the Department of Transportation (DOT) to police companies.

Upon learning of the ticket, Jack Cooper Transport discharged Brown Jr., despite the fact that his court date had not yet occurred. A grievance filed over this wrongful termination was taken to the Central and National panels where Brown Jr. was represented by Teamsters Local 89 President Fred Zuckerman and Vice-President Avral Thompson. President Zuckerman and Vice-President Thompson argued this seat belt violation, if even true, was a first-time offense and as such was not enough for a discharge. Ultimately the case was deadlocked and scheduled for arbitration.

After the grievance was deadlocked, but prior to the arbitration, Brown Jr.'s court date came, and his ticket was dismissed. Following this, Jack Cooper Transport's case crumbled, and the company agreed to settle the grievance. Teamsters Local 89 fully believes the facts were on our member's side even prior to this, and that the case would have been won if it had indeed proceeded to arbitration.

We are happy that Brother Brown Jr. was able to return to work in such a relatively short period of time, and that his case was resolved to his complete satisfaction.



Non-Union Carhaul Picket Successful

On the afternoon of January 9th, Teamsters Local 89 learned that two non-union carhaul trucks from Class Custom Carriers LLC were attempting to perform union work at the Ford LAP plant.



Unfortunately for Class, Vice President Avral Thompson and Business Agent Jason Cooper were on the property hearing grievances when this occurred. They were joined by President Fred Zuckerman, Business Agent Rick Curtis and several members to form a picket line around the two trucks which were loading up alongside Fern Valley Road.

UAW 862 members also offered support, including a UAW committee chairperson who came out to the picket line to discuss the situation with President Zuckerman and Vice President Thompson.

Ultimately, Local 89's actions were a success as Ford chose to remove the two non-union carhaulers from the premises rather than risk a standoff with the Teamsters.

Teamsters Local 89 is proud of the fact that there are no non-union carhaulers in our jurisdiction, and we intend to keep it that way!



is between a Local Union and the International Union, or how the International functions. In this article, we will explore some of the specifics and give a brief overview of the International Union.

IBT Structure

The IBT is structured into three primary sections.

- The International has jurisdiction over the entire union, and is commonly referred to as the IBT.
- Joint Councils have jurisdiction over large geographical areas, and often covers multiple states
- Local Unions have jurisdiction over smaller geographical areas and may sometimes cover sections of multiple states.

This structure is similar to the way the United States of America is set up, as seen in the images to the right. Try thinking of the International as the Federal Government, a Joint Council as a State Government, and a Local Union as a City Government. This is a fairly simple way to understand how the IBT is structured.



The International

The International Brotherhood of Teamsters (IBT) is the overall governing body of the Teamsters union. It is headquartered in Washington D.C.

The purpose of the IBT is to coordinate national contract negotiations, political action and organizing, to provide training and education programs for Teamsters officers, business agents, stewards and members, and offer advice and assistance from experienced organizers, negotiators, researches, attorneys, safety and health professionals, auditors, and communications specialists.

How the International Works

To better understand how the International works, we will now follow the chart on the next page as we walk through the hierarchy of the International union.

IBT Members

The members ultimately decide who leads the IBT, and therefore the direction our union takes, through the Teamsters General Election. This election takes place every five years, but there are a few steps along the way in this process.

IBT Delegates

The first step is for the members to elect "Delegates" from each of their Local Unions to represent them. These Delegates will attend the IBT Convention and act on behalf of the members who elected them.

IBT Convention

The IBT Convention occurs once every five years and convenes prior to the Teamsters General Election. The Convention is a very important event as this is where the elected Delegates from each Local Union will be responsible for performing very vital tasks.

The first of the Delegates responsibilities is to nominate candidates to run for the IBT General Executive Board. These candidates will be running for positions such as General President, General Secretary-Treasurer, several Regional Vice-Presidents, and many others.

Candidates must receive at least 5% of the total delegate body vote in order to be placed on the ballot for the Teamsters General Election.

IBT Constitution

The second major job of the Delegates is to vote on changes to the IBT Constitution. This is the document that governs how the Teamsters union works.

The Delegates have an enormous responsibility in this regard as any changes to the IBT Constitution will have far reaching effects across our entire union, and as such must be carefully considered.

General Executive Board

In the months following the IBT Convention, a mail in ballot for the Teamsters General Election is sent to all active members.

The results of this vote determines who is elected to the General Executive Board. This includes the election of the General President and General Secretary-Treasurer, the two most powerful positions in the Teamsters union.

General President & General Secretary-Treasurer

As you can see by the International's organizational chart, the General President and General Secretary Treasurer have an enormous amount of responsibilities all of which have a huge impact on Teamsters everywhere.

From leading the Organizing Department to determining what political action our D.R.I.V.E. fund will spend donated money on, the General President and General Secretary-Treasurer choose the direction our entire union takes.

Did you know?

Teamsters Local 89 Vice President Avral Thompson sits on the IBT General Executive Board as one of four Central Region Vice Presidents. Thompson was elected to this position in the 2016 IBT General Election.

Rev-A-Shelf Contract Ratified

Recently, members at Rev-A-Shelf overwhelmingly ratified a new four-year agreement with the Company.

Some of the highlights of the new agreement include an extended lunch period, an increased Short-Term Disability benefit, vacation hours counting towards hours worked for overtime calculations, and significant wage increases each year of the contract.

"I would like to thank the union stewards for all of their hard work with the contract negotiations," said Business Agent Roy Reynolds. "I feel we made a very good step forward from contracts in the past. It was because of all of the steward's hard work that this happened."

President Zuckerman and the Officers of Teamsters Local 89 would like to thank Roy, the Rev-A-Shelf Union Negotiating Committee, and all Rev-A-Shelf members for their solidarity and participation in this process and congratulate them on their new agreement.

As of the time this newsletter went to print, Local 89 was engaged in negotiations with Bimbo, IMI Harrodsburg and Lawrenceburg, IMI Scottsburg, Salem and Madison, and YRC.

UPS Contract Information

As we have received many questions on what the status of the UPS Contract is, we would like to take a moment to give an update as best we can.

As previously reported, the IBT considers all contracts governing Local 89 UPS Teamsters (NMA, Central Region, and Air Rider) to be ratified. While we may disagree with the IBT's position, they have shown no signs of changing their minds.

Despite this, the contract cannot move forward as there are still five supplemental contracts across the country that are not yet ratified. They are Central Pennsylvania; Upstate and West New York; Western Pennsylvania; Local 243 and Metro Detroit; and Local 804.

The IBT has reelased no timetable on when these agreements will be finished and ratified. As they are all still in negotiations it could be weeks, or even months until they are completed.

Until all of these agreements are ratified, the contracts will not be put in place and the terms of the contracts will not begin. This includes retro-pay checks. Please continue to keep track of all hours worked since August 1st as you will be owed retro-pay for all of those hours.

Did you know?

The Teamsters Emblem

Thunder and Lightning are the names of the two horses that appear behind the wagon wheel on the Teamsters emblem. This image has changed many times over the lifespan of our Union, but these horses and the wheel have been mainstays since 1910.

Now formally known as the International Brotherhood of Teamsters, the name of our Union at the time this emblem was first created was the International Brotherhood of Teamsters, Chauffeurs, Stablemen and Helpers of America. Originally, the term Teamster referred to someone who drove a team of animals in the early 1900s, such as a delivery wagon drawn by horses, and was one of the original job types our union represented. As such jobs faded away, due to the rise of automobiles, the term Teamster evolved to refer specifically to our Union and became our official name.
